

The District Council has powers under the Local Government (Miscellaneous Provisions) Act 1982 to control street trading. In accordance with the Act the Council has designated certain streets as consent or prohibited streets for the purposes of street trading.

Where a street has been designated a prohibited street no street trading is allowed. In those streets which are consent streets permission from the Council is required. These designated streets are set out in the list below. All other streets are not controlled by the District Council under the street trading powers.

Street trading means selling, exposing of, offering for sale any article in the street which includes footways and generally any area where the public have access without payment.

Some types of trade are exempt from the restrictions imposed under the Act. these include:

- a) Pedlars trading under the authority of a Pedlar's Certificate (obtained from the Police)
- b) Trade carried out by roundsmen e.g. milkmen

- News vendors trading in the sale of newspapers and periodicals only (subject to restrictions on the size of any stall)
- d) Trade at fairs and markets which have a right to trade
- e) Trade at Petrol Stations and
- f) Trade carried out in a street adjoining a shop provided it is part of the business carried out by the shop (there may be specific planning restrictions on such trade).

To trade on a consent street requires a specific consent from the Council to operate in an identified location. The Council has identified two locations which it deems suitable for street trading, consents have been granted to the current operatives in these locations.

There are other powers under which the County Council, as Highway Authority, and the Police may control trading from any of the streets not controlled by the District Council. There is also other legislation under which the District Council monitors trading particularly the sale of food under Environmental Health requirements.

Prohibited Streets

1. Skegness Area

Except where indicated, the whole of the lengths of the following streets including the private forecourts, footways, open areas, open spaces, car parks or other areas adjoining or adjacent to those streets to which the public have access without payment.

- a. Lumley Avenue from its junction with Lumley Road in a northerly direction to the junction with Rowletts Circus (Scarbrough Avenue).
- b. Lumley Square.
- c. Richmond Drive from its junction with Lumley Square in a southerly direction to its junction with Sandbeck Avenue.
- d. Roman Bank (A52) from its junction with Lumley Square in a northerly direction to its junction with Castleton Boulevard.



- e. Roman Bank (A52) from its junction with Winthorpe Avenue in a northerly direction to its junction with Seathorne Avenue.
- f. Wainfleet Road (A52) from its junction with Lumley Square in a westerly direction to its junction with Dorothy Avenue.
- g. Winthorpe Avenue.

2. Chapel St. Leonards

- a. Ancaster Avenue
- b. South Road
- The whole of the Village Centre as shown indicated red on the plan on deposit at Tedder Hall, Manby.

3. Ingoldmells

- a. Anchor Lane
- b. Chapel Road
- c. High Street
- d. Old Roman Bank
- e. Roman Bank
- f. Sea Lane (including part on seaward side of Roman Bank)
- g. Skegness Road

4. Mablethorpe

- a. George Street, from its junction with High Street in a southerly direction to the junction with Knowle Street
- b. High Street, except the length between its junction with George Street and the junction with Seacroft Road.
- c. Quebec Road
- d. Seacroft Road
- e. Victoria Road

5. Sutton on Sea

- a. High Street
- Marine Avenue, from its junction with Cromer Avenue in a north easterly direction to the junction with Trusthorpe Road

- c. Station Road
- d. Trusthorpe Road
- e. York Road

6. Trusthorpe

a. Sutton Road

7. Skegness

- a. Arcadia Road
- b. Barbara Road
- c. Beresford Avenue, from its junction with Lumley Road in a southerly direction to the junction with Lawn Avenue
- d. Briar Way from its junction with High Street in a southerly direction to the southern limit of the Lawn Car Park
- e. Castleton Boulevard
- f. Drummond Road, from its junction with Lumley Road in a southerly direction to its junction with Sandbeck Avenue
- g. Edinburgh Avenue
- h. Grand Parade
- i. High Street
- j. Lumley Road
- k. North Parade
- I. Prince Alfred Avenue
- m. Rutland Road, from its junction with Lumley Road in a northerly direction to the northern limit of the Tower Gardens
- n. Sandbeck Avenue
- o. Scarbrough Avenue, from St. Matthew's Church in an easterly direction to the junction with Grand/North Parade
- p. Seaview Road
- g. Serena Road
- r. South Parade

Consent Streets

Except where indicated, the whole of the lengths of the following roads within the District of East Lindsey including lay-bys and highway verges:

A157, A158, A153, A155, A16, A1031, A631

A1104, except the length in the Parish of Mablethorpe known as High Street. (excluding the length between the junctions with George Street and Seacroft Road; this length is a consent street).

A52 except the lengths:

- a. in the Parish of Ingoldmells known as Chapel Road, High Street, Roman Bank and Skegness Road;
- b. in the Parish of Mablethorpe known as Victoria Road;
- c. in the Parish of Sutton on Sea known as High Street, Station Road and Trusthorpe Road;
- d. in the Parish of Trusthorpe known as Sutton Road.
