<u>Re: Report and recommendations from the Lincolnshire Police and</u> <u>Crime Panel on the Police and Crime Commissioner for Lincolnshire's</u> <u>Annual Report 2021–22</u>

On behalf of the Lincolnshire Police and Crime Panel I would like to thank you and your colleagues (Joanne Davison – Director of Strategy and Operations and Julie Flint - Chief Finance Officer) for your attendance at the Panel's meeting on 18th November 2022 to present and discuss your Annual Report for 2021-22.

As required by section 28 (4) of the Police Reform and Social Responsibility Act 2011, I write to report on the Panel's response to the Annual Report. As is customary practice, a copy of this letter will be published on the Panel's website.

As you are aware, at each Panel meeting in 2021/22 the Panel received a Police and Crime Plan (the Plan) progress report. It undertook thorough, robust and supporting reviews of these reports to ensure that the ambitions within your Plan were being proactively delivered. Details of these reports and reviews are available via the Panel's website.

In summary the Panel is satisfied that the Annual Report for 2021-22 reflects the progress and achievements that have been delivered against the 4 key principles contained in the Plan.

At our recent meeting, the Panel focussed the majority of it's questioning on your work and future delivery of the Plan. The Panel asked you questions relating to:

- Links between environmental crime and access to recycling centres, and if shorter opening hours were significant;
- Joint Diversionary Panel and continued support for the Out of Court Disposal Scrutiny Panel;

- Mutual Gain Initiative and the next steps;
- Lincolnshire Independent Custody Visiting Scheme and resumption of face to face visiting;
- Analysis on the rise of thefts of vehicles and the use of drones in rural areas by thieves targeting agricultural vehicles;
- Custody visiting scheme;
- Targets and league tables;
- Clear up rates for burglary and grievous bodily harm;
- Complaints against the Police;
- Police Forces in special measures and the use of League Tables

Further to this questioning the Panel requested the following information be provided to the Panel:

- 1. Clear up rates relating to burglary, home burglary and grievous bodily harm when the appropriate data is available;
- 2. Mutual Gain Initiative Following a piece of work to detail specifics, an update in due course;
- 3. Complaints against the Police the number of complaints upheld.

We look forward to receiving a further progress report on delivery of the Police and Crime Plan 2021 - 2025 at our meeting on 3^{rd} February 2023.
