Advocates' Joint Note on Programme

- 1. The Advocates have corresponded on the order of the evidence and likely timings, having regard to the CMC and a topic-based Inquiry. The Advocates are also aware of the Inspector's question on the adequacy of the 6-day time window which is presently charted for this Inquiry.
- 2. The programme which is set out below is proposed jointly for the Inspector to consider. The Hatton Action Group request that additional provision for interested persons who cannot appear on the first day is made in a late-afternoon/early evening slot, and to ensure time is available for those who may be working or otherwise unavailable during the day. We have not included a slot for the site view, but there are several options for that.
- 3. The Advocates presently consider that six days suffices.
