The Council of the district of East Lindsey in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, with the consent of the Lincolnshire County Council in accordance with Section 39(3) of the Act, and after consultation with the Chief Officer of Police in accordance with part III of Schedule 9 to the Act, hereby makes the following Order:-

 The East Lindsey (Off-Street Parking Places)(Civil Enforcement)(Consolidation Order) 2014 ('The Order') shall be further amended as follows:-

(a) Tower Esplanade Car Park, Skegness

To be added to the Parking Order. Charging hours and tariff is set out at Schedule 1 to this order. The Tower Esplanade car park is shown edged red on the attached plan 1 in Schedule 2 to this order.

(b) Pierside Car Park, Skegness

The removal of the area known as Pier Field from the Pierside Car Park, Skegness. The revised extent of the Pierside Car Park is shown edged red on the attached plan 2 in Schedule 2 to this order.

(c) Swimming Pool Car Park, Skegness

The inclusion of additional areas of land to alleviate parking problems. The revised extent of the Swimming Pool Car Park is shown edged red on the attached plan 3 in Schedule 2 to this order.

(d) Seacroft Car Park, Mablethorpe

The introduction of height restrictions at the Seacroft Car Park, Mablethorpe. The height restriction is to be set at 2.05 metres. The Seacroft Car Park is shown edged red on the attached plan 4 in Schedule 2 to this order.

(d) Overnight Car Parking


Overnight parking charges in all East Lindsey District Council car parks are to be removed.






